Software License Agreement
“PID Verificator 1.0.1”

The terms and conditions contained herein constitute a legal agreement. This agreement (“AGREEMENT”) contains the entire agreement between the licensee (“YOU”) and the licensor pnb plants & bytes GmbH (“PNB”) with respect to the terms and conditions described herein.

Read AGREEMENT carefully. By downloading or installing or using the PID Verificator Software (“SOFTWARE”), YOU acknowledge that (1) YOU are authorized to enter AGREEMENT for and on behalf of your company, and are doing so, and (2) YOU have read and understand and agree that YOU and your company shall be bound by the terms and conditions of AGREEMENT and all modifications and additions provided for.

§ 1 License Grant

- 1.1 PNB grants YOU a permanent, irrevocable, non-exclusive, non-transferable license at no charge to use SOFTWARE and related documentation for the purpose of checking the correctness of Proteus XML files according to the DEXPI Specification 1.3, subject to the terms and restrictions set forth in this AGREEMENT.
- 1.2 YOU are not permitted to use SOFTWARE and/or related documentation in any manner not expressly authorized by AGREEMENT.

§ 2 Term of Agreement

- 2.1 YOUR license will terminate automatically if you fail to comply with any of the limitations or other requirements described herein.
- 2.2 At termination you shall cease all use of SOFTWARE as well as related documentation and destroy all full or partial copies.

§ 3 Ownership Rights

- 3.1 Except for included third party components, SOFTWARE and related documentation are protected by copyright laws of the Federal Republic of Germany and international treaties.
- 3.2 Except for included third party components, PNB owns and retains all right, title and interest in and to SOFTWARE as well as related documentation, including all

copyrights, patents, trade secret rights, trademarks and other intellectual property rights therein.

- 3.3 With respect to included third party components, the corresponding providers retain all right, title and interest in and to their components and related documentation, including all copyrights, patents, trade secret rights, trademarks and other intellectual property rights therein.

§ 4 Use of Name and Trademarks

- 5.3 YOU may not modify, reverse engineer, decompile, or disassemble SOFTWARE and/or related documentation.
- 5.4 Certain components of SOFTWARE are provided under various open source licenses that have been made available to PNB. These components are licensed to YOU by their authors. Please refer to the licenses of these components for the terms of use before using SOFTWARE.
- 5.5 PNB is not obligated to provide any maintenance, technical or other support for SOFTWARE and/or related documentation or for any component as described in Section 5.4.

§ 6 Exclusion of Warranties

- 6.2 PNB makes no warranties relating to SOFTWARE or related documentation and expressly disclaims all warranties, express or implied, including without limitation those of merchantability and fitness for a particular purpose.

§ 7 Limitation of Liability

- 7.1 In no event shall PNB be liable for any incidental, special, indirect or consequential damages whatsoever, including, without limitation, damages for loss of profits, loss of data, business interruption or any other commercial damages or losses, arising out of or related to YOUR use or inability to use SOFTWARE and/or related documentation, however caused, regardless of the theory of liability (contract, tort or otherwise) and even if PNB has been advised of the possibility of such damages.

- 11.4 Aachen is the exclusive place of jurisdiction for all disputes arising from and in connection with this contract.

Preamble
